## Carry-Over Resolution 2023-03 To Amend Sec. 20.10 B.L.

**Statement of Purpose:** To remove the Masonic Development Program (MDP) as a codified alternative to proficiency.

**Resolution:** This would remove the paragraph that suggests the MDP may be offered in place of the Standard Posting Lecture as proof of proficiency.

**Whereas:** The Washington Masonic Code provides the minimum standards for proficiency as; demonstrated knowledge of the obligation, signs, words and grips and all modes of recognition of each Degree (Sec. 20.10 B.L.), and

Whereas: The Washington Masonic Code states that the Lodge is the sole judge of proficiency in the preceding Degree, ascertained by examination, either in open Lodge or by a committee appointed by the Master (Sec. 20.10 B.L.), and

Whereas: The Masonic Development Program is not only the Degree Education elements, and

Whereas: The MDP is intended to further education, and

**Now, Therefore, be it Resolved,** that Sec. 20.10 B.L. be amended to read as follows:

#### Sec. 20.10 B.L.

## Proficiency in the Degrees.

No candidate shall be passed to the Degree of Fellowcraft nor raised to the Sublime Degree of Master Mason without proof of proficiency in the preceding Degree. As a minimum, a candidate must be able to demonstrate knowledge of the obligation, signs, words, and grips and all modes of recognition of each Degree.

The Lodge shall be the sole judge of the proficiency of the candidate in the preceding Degree, which shall be ascertained by examination, either in open Lodge or by a committee appointed by the Master of the Lodge and recorded by the Secretary.

(The candidate may be offered the Masonic Development Program approved by the Grand Lodge in place of the Standard Posting Lecture as proof of proficiency at the option of the Lodge.)

(Regardless of which method of determining proficiency is selected,) Every candidate progressing through the Degrees will be furnished a copy of the Masonic Development Program by his Lodge.

After being raised as a Master Mason the Brother shall pay his dues for the current year as established in the Lodge By-Laws and sign the By-Laws, whereupon he becomes an enrolled member of the Lodge.

**Report of the Committee on Jurisprudence:** This Resolution is consistent with Masonic Law and Usages and is ready for consideration by the Grand Lodge. The Committee expresses no opinions as to the wisdom of the changes this Resolution proposes. As a carry-over Resolution this By-Law Amendment requires a simple majority affirmative vote for adoption.

**Report of the Committee on Finance:** The Committee on Finance, to whom was referred carry-over Resolution 2023-03 has considered the same and reports as follows; this resolution would require a minor edit to the printed Washington Masonic Code and the costs involved would be negligible.

## Carry-Over Resolution 2023-06 To Add Sec. 13.15 B.L.

**Statement of Purpose:** This resolution provides a framework for Lodges under the Grand Lodge of Washington to adopt and implement programs for virtual Lodge attendance.

**Resolution:** To add Sec. 13.15 B.L. to authorize and provide guidance regarding virtual Lodge attendance.

**Whereas:** During the global Covid-19 pandemic, Masonic Lodges began to explore options and strategies for virtual Lodge attendance, and Lodges found that virtual attendance helped to make Freemasonry accessible and available to Brothers who are incapable of physically attending Lodge meetings, and

**Whereas:** Virtual Lodge attendance programs need to be carefully adopted and implemented to facilitate Lodge attendance while protecting the secrecy and solemnity of Masonic ritual, and

**Whereas:** The Washington Masonic Code does not presently contain guidance regarding virtual Lodge attendance and, therefore, questions regarding virtual Lodge attendance have been resolved outside of the Code and by each newly installed Grand Master, and

Whereas: Making provision for virtual Lodge attendance within the Washington Masonic Code will better enable Lodges to adopt and implement programs for virtual Lodge attendance, and

**Now, Therefore, be it Resolved,** that the following Sec. 13.15 B.L. be added to read as follows:

## Sec. 13.15 B.L.

<u>Virtual Lodge Attendance</u>. The Master of a Lodge may authorize the Lodge to allow Brothers to participate in the discussion of business and educational portions of a Stated or Special Meeting through the use of telephonic, videoconference, or other electronic means ("Virtual Lodge Attendance"). The Master of a Lodge need not declare a Lodge Off-Session to permit Virtual Lodge Attendance.

A. The Master of a Lodge may permit Virtual Lodge Attendance, subject to the following provisions:

- 1. No Mason who is engaged in Virtual Lodge Attendance shall be permitted to fill an officer's place or station.
- 2. Before admitting any Brother to Virtual Lodge Attendance, the Master of a Lodge shall satisfy himself that each such Brother is entitled to attend the meeting. The Master of a Lodge shall ensure that all Brothers participating in Virtual Lodge Attendance are noted as having been in attendance in the Tyler's Register; the Master of a Lodge shall include a notation indicating that those Brothers attended the meeting via Virtual Lodge Attendance.
- 3. Virtual Lodge Attendance shall be permitted solely for discussion of the business and educational portions of a meeting; Virtual Lodge Attendance shall not be permitted during any portion of a meeting wherein Masonic ritual is performed (*e.g.* opening, calling up/down, balloting, or closing).

- 4. The Master of a Lodge shall ensure that no ritual aspects of Lodge attendance are visible/audible by any Brother who is participating in Virtual Lodge Attendance; the Master of the Lodge may accomplish this in any manner that he believes best suited to the circumstances of his Lodge (e.g. placement of camera to ensure that no ritual entrance or departure from the Lodge can be viewed or assignment of a Brother to pause camera transmission during ritual aspects of Lodge attendance).
- 5. Brothers participating in Lodge by Virtual Lodge Attendance shall not be entitled to introduce any proposal requiring a vote nor vote on any matter put before the Lodge, and a Brother who is participating in Virtual Lodge Attendance shall not be considered in attendance for purposes of Sec. 13.06 B.L., requiring universal balloting on specified matters.
- 6. The Master of a Lodge shall make provision (whether by camera placement and/or seating position) for any Brother who does not want his likeness to be electronically transmitted while he is in Lodge.
- 7. No aspect or portion of a meeting may be recorded as a result of Virtual Lodge Attendance, and the Master of a Lodge shall ensure that the recording features, if any, of the software or service used for Virtual Lodge Attendance are disabled.
- B. A Brother participating in Virtual Lodge Attendance shall ensure that he is participating from a sufficiently private location that eavesdropping is not reasonably likely.

**Report of the Committee on Jurisprudence:** This Resolution is consistent with Masonic Law and Usages and is ready for consideration by the Grand Lodge. The Committee expresses no opinions as to the wisdom of the changes this Resolution proposes. As a carry-over Resolution this By-Law Amendment requires a simple majority affirmative vote for adoption.

**Report of the Committee on Finance:** The Committee on Finance, to whom was referred carry-over Resolution 2023-06 has considered the same and reports as follows; this resolution, if adopted, would require an edit to the text of the Washington Masonic Code. The costs involved in this would be minimal other than the cost of reprinting the affected pages.

#### Carry-Over Resolution 2023-07 To Amend Sec. 7.03 B.L.

**Statement of Purpose:** To implement the Grand Master's Recommendation No. 1 to ensure adequate funds are available to support the Grand Lodge Budget.

**Resolution:** To increase the annual Grand Lodge assessment charged for each chargeable member and stabilize the funding of Grand Lodge.

**Whereas:** The total number of chargeable members has declined by approximately 45% over the last ten years, and

**Whereas:** Over the last ten years, an average of 48.80% of our funding has come from the Endowment Fund Management Fee, 27.29% has come from the Grand Lodge Membership Fee and 23.91% has come from the Endowed Life Membership Fund, and

**Whereas:** The proportion of funding from the General Fund Fee has been increasing from year to year and the proportion of funding the Grand Lodge Fee has been declining due to the decline in chargeable members, and

**Whereas:** Growth in the market value of our investments between 2012 and 2022 has enabled us to more than offset the decline in income from chargeable members, and

**Whereas:** The Grand Lodge Budget has only increased a total of 33.63% between 2012 and 2022 (3.36% per year). This is in line with the average rate of inflation of 2.64% per year, and

**Whereas:** This change will allow us to reduce our dependence on Endowment Fund Management Fund Fees and Endowed Life Membership Fees as a source of funding, and

Whereas: The fiscal impact per assessable member is less than 4 cents per day per year at the end of the four (4) year period, and

**Now, Therefore, be it Resolved,** that Section 7.03 B.L. be amended as follows:

#### Section 7.03 B.L.

#### **Revenue for the General Fund**

- A. Every Lodge shall pay into the treasury of the Grand Lodge in support of Grand Lodge general activities the following:
  - 1. through 5. (No Change)
  - 6. A sum to be set annually by the Grand Lodge [but not to exceed (twenty eight dollars and no cents (\$28.00)) thirty-one dollars and no cents (\$31.00) which amount will increase three dollars (\$3.00) each year until it reaches forty dollars and no cents (\$40.00)] for each enrolled Master Mason, except those whose dues are remitted or not required for any reason. One dollar (\$1.00) shall be designated for contribution to each of the following organizations: the George Washington Masonic National Memorial Association, Washington/Idaho International Order of the Rainbow for Girls, Job's Daughters International of Washington and Washington Order of DeMolay.

The exceptions are: Rev. 2017

- a. through g. (No Change)
- 7. (No Change)

## B. through D. (No Change)

**Report of the Committee on Jurisprudence:** This Resolution is consistent with Masonic Law and Usages and is ready for consideration by the Grand Lodge. The Committee expresses no opinions as to the wisdom of the changes this Resolution proposes. As a carry-over Resolution this By-Law Amendment requires a simple majority affirmative vote for adoption.

**Report of the Committee on Finance:** The Committee on Finance, to whom was referred carry-over Resolution 2023-07 has considered the same and reports as follows; if adopted, this resolution will reduce our dependance on income derived from our various investment funds and allow those monies to remain in their respective funds. This will serve to enhance their returns over time.

## Carry-Over Resolution 2023-11 To Amend Sec. 14.03 Const.

**Statement of Purpose:** To implement the Grand Master's Recommendation No. 5 to limit voting on Lodge By-Laws to Members in good standing.

**Resolution:** To ensure that only members of a Lodge who are current in payment of Lodge dues and assessments are entitled to vote on Lodge By-Laws.

Whereas: Currently the Washington Masonic Code does not specifically define "good standing", and

**Whereas:** Resolution 2023-10 addresses proposed By-Law changes related to definition of Good Standing and this resolution addresses Constitutional changes, and

**Whereas:** It is generally understood that only Master Masons who are current on their dues are allowed to be installed as officers of a Lodge because only Master Masons in "good standing" may be officers of a Lodge per Sec. 15.03 B.L., and

**Whereas:** Twenty (20) sections of the Washington Masonic Code currently refer to Masons being in "good standing." These are Sections 3.05 Const., 4.03 B.L., 7.03 B.L., 13.01 B.L., 14.03 Const., 15.02 B.L., 15.03 B.L., 16.01 B.L., 16.18 B.L., 17.02 B.L., 17.03 B.L., 17.04 B.L., 17.05 B.L., 17.06 B.L., 17.10 B.L., 17.11 B.L., 17.12 B.L., 23.01 B.L., 25.09 B.L., and 28.01 B.L., and

Whereas: The Lodge dues are "payable in advance of the first day of January of each year", and

**Whereas:** A member of a Lodge continues to be so until he is dropped for nonpayment of dues, is suspended or expelled, dimits, or dies, and

**Whereas:** The failure to pay dues when dues can be a hardship for the Lodge because its budget is predicated upon the timely receipt of dues income, and

**Now, Therefore, be it Resolved,** that Sec. 14.03 Const. be amended to read as follows:

Sec. 14.03 Const. By-Laws.

- A. through B. (No Change)
- C. A minimum of two-thirds (2/3) of the votes cast by <u>members in good standing</u> must be favorable for the approval of a change of By-Laws, **Rev. 2013**
- D. through G. (No Change)

**Report of the Committee on Jurisprudence:** This Resolution is consistent with Masonic Law and Usages and is ready for consideration by the Grand Lodge. The Committee expresses no opinions as to the wisdom of the changes this Resolution proposes. As a carry-over Resolution this Constitutional Amendment requires a two-thirds affirmative vote for adoption.

**Report of the Committee on Finance:** The Committee on Finance, to whom was referred Resolution 2023-11 has considered the same and reports as follows; this resolution, if adopted, would require an edit to the text of the Washington Masonic Code. The costs involved in this would be minimal other than the cost of reprinting the affected pages.

## Carry-Over Resolution 2023-13 To Amend Sec. 21.05 B.L.

**Statement of Purpose:** To implement the Grand Master's Recommendation No. 7 to require the approval of the Grand Master, the Grand Lodge Committee on Finance, and the Grand Lodge Real Estate Advisory Committee to approve the purchase, sale, transfer, receipt, or disposal of real property held by a Lodge or Title Holding Corporation.

**Resolution:** To provide the support of the Finance Committee and Real Estate Advisory Committee for Lodges and Title Holding Corporations for the purchase, sale, transfer, receipt, or disposal of real property.

Whereas: Currently the Grand Lodge Finance committee is required to review any purchase of any real property, but is not required to review any sale of property, and

**Whereas:** The sale of real property can be complicated with many potential pitfalls with financial and legal consequences that may require professional advice in navigating these issues, and

Whereas: Lodges and Title Holding Corporations may not have the expertise or experience with the purchase, sale, transfer, receipt, or disposal of real property, and

Now, Therefore, be it Resolved, that Section 21.05 B.L. be amended to read as follows:

#### Sec 21.05 B.L.

**Real Property.** A Lodge may acquire and hold real property for its use and benefit, but only when title to the real property is placed in the name of a Title Holding Corporation.

No Masonic corporation shall acquire any real property by means of purchase, donation, inheritance or by any other means until it has obtained a Phase 1 Environmental Site Assessment (ESA) that satisfied the American Society for Testing and Materials (ASTM) Phase 1 standard, in use and approved at the time it is performed. In obtaining the Phase 1 ESA, the Masonic corporation shall use, and hire, at its sole cost and discretion, one of the environmental consulting firms approved by the Grand Lodge. Upon completion of such Phase 1 ESA and any additional investigation recommended in the Phase 1 ESA, all reports shall be forwarded to the Grand Lodge Committee on Finance for approval. Rev. 2013

Lodges that hold title to real property in the Lodge's name as of June 15, 2007, shall transfer title to such real property to a Title Holding Corporation formed in a manner consistent with Sec 21.08 B.L. Such transfer shall be completed no later than June 1, 2008, unless the Grand Master waives the requirement.

No Lodge or Title Holding Corporation shall (sell, transfer, or dispose of any real property unless approved) undertake the purchase, sale, transfer, receipt, or disposal of any real property without the written approval of the Grand Master, the Grand Lodge Committee on Finance, the Grand Lodge Real Estate Advisory Committee, and the approval of the Lodge and Title Holding Corporation, if applicable, as follows:

- A. Real property that is owned by a Title Holding Corporation requires the approval of at least three-fourths (3/4) of the Trustees present at a meeting of the Trustees at which a quorum is present and two-thirds (2/3) approval of the members of each Lodge that is a member of the Title Holding Corporation. The Lodge shall provide its members at least twenty (20) days advance notice of the stated meeting of the vote.
- B. Real property that is owned by a Lodge requires the approval of two-thirds (2/3) of the members of the Lodge present at a stated meeting of the Lodge. The Lodge shall provide its members at least twenty (20) days advance notice of such vote. The requirement of twenty (20) days advance notice shall be waived if the transfer of title is to a Title Holding Corporation.

**Report of the Committee on Jurisprudence:** This Resolution is consistent with Masonic Law and Usages and is ready for consideration by the Grand Lodge. The Committee expresses no opinions as to the wisdom of the changes this Resolution proposes. As a carry-over Resolution this By-Law Amendment requires a simple majority affirmative vote for adoption.

**Report of the Committee on Finance:** The Committee on Finance, to whom was referred Resolution 2023-13 has considered the same and reports as follows; this resolution, if adopted, would add an additional level of review to all Real Estate transactions undertaken by Lodges or Title Holding Corporations. As such, there would be no cost impact per se to the Grand Lodge or the parties involved.

## Carry-Over Resolution 2023-14 To Amend Sec. 26.09 B.L.

**Statement of Purpose:** To implement Grand Master's Recommendation No. 8 to allow the Grand Master to determine if charges referred by a Lodge against a Brother constitute un-Masonic conduct.

**Resolution:** To amend Sec. 26.09 B.L. of the Washington Masonic Code (WMC) - Disposition of Charges to allow the Grand Master to determine whether charges levied against a Brother by a Lodge constitute un-Masonic conduct.

**Whereas:** Chapter 26 addresses the procedures of how charges for un-Masonic conduct are preferred in a Lodge, and how they are forwarded to the Grand Master for referral to the Grand Lodge Trial Committee, and

**Whereas:** Chapter 26 provides for a procedure to appeal to the Grand Master if the charges are not accepted by the Lodge (Sec. 26.09 (C) B.L.), and

Whereas: Chapter 26 does not provide for a procedure to allow the Grand Master to review the charges referred by a Lodge to determine if, in his opinion, the actions do in fact constitute a Masonic offense (such as probable cause in a criminal court matter), and

Now, Therefore, be it Resolved, that Sec. 26.09 B.L. be amended as follows:

Sec. 26.09 B.L. Disposition of Charges

A. and B. (No Change)

C. The Lodge shall, at the Stated Communication when the charges are presented and read, vote upon the question of whether or not the charges, if proved, constitute a Masonic offense. If a majority of the members present vote that the charges, if proved, constitute a Masonic offense, the charges shall be deemed accepted by the Lodge. In the event that the charges are not accepted, any Mason feeling aggrieved thereby, may appeal from the decision of the Lodge to the Grand Master, solely upon the question of whether or not the charges as drawn, if proved, constitutes a Masonic offense.

The Grand Master, having received an appeal from an aggrieved Mason under the provisions of this section, and having determined that the charges, if proved, constitute a Masonic offense, shall forward the appeal to the Grand Lodge Trial Committee to try the accused upon the charges. If the charges are not found to constitute a Masonic offense the Grand Lodge Trial Committee will inform the Grand Master, who will then notify the Lodge and the aggrieved Mason of his decision. In addition, upon receipt of the charges from the Lodge, the Grand Master may review the same to determine if the charges preferred constitute a Masonic offense. If the Grand Master determines that they do not constitute a Masonic offense, they shall not be referred to the Grand Lodge Trial Committee but shall be returned to the Lodge for further discussion; and

D. (No Change)

## Resolution 2024-01 To Amend Sec. 15.05 B.L.

**Statement of Purpose:** To allow Lodges meeting in early June to elect, and should they wish, install officers during the months of June, July, and August, an ability that is currently allowed few Lodges.

**Whereas:** Section 15.05 B.L. currently provides for the election and therefore the possible installation of Lodge officers starting the Monday following the close of Grand Lodge, and

Whereas: Research shows that of a majority of the urban lodges and a number of others as well, hold their stated meeting during the first two weeks of the month, that a great many of these Lodges suspend meetings in July and August, and

**Whereas:** Section 15.05 B.L. excludes these Lodges from electing officers in June and should they so desire, opt for a special communication to install officers until their fall stated meeting, and

Now, Therefore, be it Resolved, that Section 15.05 B. L. be amended to read as follows:

Sec. 15.05 B.L.

When To Elect Officers. The elective officers of every Chartered Lodge shall be chosen annually at a Stated Communication of such Lodge during the period beginning June 1<sup>st</sup>, (the first Monday after the close of Grand Lodge) and ending December 14. However, officers shall not be installed in their respective offices until the first Monday following the close of the Grand Lodge Annual Session.

**Now, Therefore, be it Resolved,** that Section 17.21 B.L. be amended to read as follows:

## **Length of Membership Recognition**

A. through E. (No Change)

F. <u>Length of membership recognition may be requested by the Lodge up to one month prior to the month of eligibility.</u>

<u>FG.</u> The presentation may be made at the will and pleasure of the Lodge during the month of eligibility or any time thereafter. A Mason of fifty years, or longer membership, shall be eligible for recognition any time after January 1 of the year in which he becomes eligible.

# Resolution 2024-03 To Amend Section IV, Division VI of the Standard Work

**Statement of Purpose:** To replace the current Division VI, Funeral Service, Pages 4-39 to 4-57, with an updated, concise, multi-purpose format for the memorial and funeral service.

**Resolution:** The purpose of the memorial or funeral service is to allow the Masons from a Masons Home Lodge, on short notice, if necessary, to perform a relevant and honorable ceremony that demonstrates to the family, friends and fellow Masons the esteem which we hold for the fallen brother.

**Whereas:** The existing options are outdated in terminology and directions and emphasize memory work only, and

Whereas: Lodges, and even Districts, cannot provide a fully trained team of Brothers to perform this ceremony on short notice, and

**Whereas:** Freemasons (and society) have adopted very different views of funeral services and the verbiage within the different optional services provides no clear and concise format to present a timely, involving and relevant service to honor a departed Brother, and

**Whereas:** The purpose is to provide a ceremony that Masons can perform well on short notice, in different locations, and is consistent in verbiage and directions, and

**Now, Therefore, be it Resolved,** that Section IV, Division VI, Funeral Service, pages 4-39 to 4-57 of The Standard Work be now replaced in its entirety as follows:

## <u>Masonic Memorial Service</u> Suitable for Lodge, Church, Funeral Home or Graveside

Introduction: Conferring the last degree upon a Brother is one of the greatest privileges we as Masons can perform. It is a celebration of life for a man who lived respected and who has passed regretted. With this in mind, there are many factors that need to be considered prior to conferring it. First: You must receive the blessing of the family. It is about their wishes--not the Lodge's. If they agree, then the Lodge will be demonstrating to his family and friends the respect we have for him—and our thanks to them for sharing him with us. The parts as they are written below are from The Standard Work (TSW), but the sequence has been revised. Several reasons, but mainly, some "services" are too short, while others are too long—and with very archaic words. This is an attempt to consolidate the various Masonic services in TSW into one version which is respectful; engaging to the family; time conscious; demonstrates some of our ritual and symbols; and has a small bit of drama. It will run 12-15 minutes, and with adapting, is suitable for one person or up to six (6) or seven (7) people to perform.

This is not about memorized ritual. There are three main reasons: 1) These services are not performed often enough for memory to be retained; 2) Prompting during a regular degree is bad—during this degree, it is embarrassing; 3) Read well, with sufficient practice, it is more engaging for the team and the family. The family cares about two things: 1) You demonstrate your love and care; 2) You are prepared! Every speaking part should be read aloud twenty-five (25) times in the days prior!

The location for the service will rarely be the same. Arrive early, look at the physical layout, have discussion with his family. Consider options for what may work best: where to stand—usually to one side; a small

table? Who has the Acacia? Plain White Aprons are best. Dark suit and tie. If you are co-officiating with a clergyperson because of the wishes of the family, defer to them about sequence—who goes first, etc. With clergy present—it is suggested that the Masonic prayers be shortened. If there is a Military presence—defer to them about going first. At a National Cemetery—the total service is limited to twenty-two (22) minutes. Be prepared to adapt!

It is recommended that the WM for the degree be prepared to speak to those in attendance, before and during the degree, in his own voice and words, some of what the Masons will be doing. Explain briefly that Masonry is taught using symbols and allegories—several of which will be demonstrated today. And that these symbols have a literal meaning but also a more powerful emotional meaning, unique to each person. Remind them that our fallen Brother lived his life according to these ideals.

Done well and with genuine love, the last degree demonstrates our commitment in Brotherhood to each other and is a reminder of what others may also do so for us someday. Make it an integral part of your Lodge culture. Remember--you do not know when the call will come to perform this degree, so be prepared!

The marks { } in the following text indicate where the degree team may choose to share responsibility for the speaking part with someone else on the team.

## Beginning of Service:

WM: (Brief preparatory remarks, thanks for attendance, turn off cell phones, and thanks to the family for allowing their husband, father to be a part of our lives.)

From time immemorial it has been the custom of the Society of Free and Accepted Masons, on proper request, to accompany the remains of a Brother to their final resting place. In conformity with this ancient usage, and in accord with our loving duty to our Brother, we are assembled here as Masons and family to offer tribute of our affection and to testify before the world our faith in the Almighty Father and his beneficent goodness to us, His children.

SW: { } With becoming reverence, then, let us supplicate the divine Grace to insure the favor of that Eternal Being whose goodness and power knows no bounds; that on the arrival of the momentous hour when the fading taper of human life shall faintly glimmer in the socket of existence, our faith may draw aside the sable curtain, and our hope may sustain and cheer the departing spirit.

Chaplain: Almighty and Eternal God—in Whom we live and move and have our being, we beseech Thee to be present with us in this hour and during all the hours of our earthly life; lead us by the hand of love; point out to us the pathway of duty. Pour out Thy continual blessing upon the relatives and friends of our departed brother. Lead them to know that He is waiting to greet them in a world where light and bliss are eternal. {If you need to shorten prayers—stop here} Give wisdom to direct us, strength to support us, and the beauty of holiness to adorn our labors and render them acceptable in Thy sight, so that when our labors here on earth are ended, we may be with Thee amidst the radiant splendor of eternal truth. Amen!

Response: So mote it be.

WM: Brother Senior Warden, in this hour of sorrow what duties devolve upon us as Masons?

SW: To honor the memory of a Brother whom death has taken from us; to contemplate our own approaching dissolution; and, by the remembrance of immortality, to raise our souls above the considerations of this transitory existence.

WM: Brother Junior Warden, what sentiments should inspire the souls of Masons on occasions like the present?

JW: Calm sorrow for the absence of a Brother gone before; earnest solicitude for our own eternal welfare; and firm faith in the wisdom and goodness of the Great Architect of the Universe.

WM: Brother Secretary, has a scroll been prepared, that the memory of our Brother may not depart from us?

SEC: It is hereon written and shall also be preserved in our archives.

WM: You will read the scroll and place it with the remains of our Brother. (Secretary reads and deposits scroll. (Retain extra copies for widow/ family/ Lodge)

<u>Chaplain:</u> O Thou that hearest prayer, unto Thee shall all flesh come. Let Thy mercy, Oh Lord, be upon us according as we hope in Thee. Amen.

Response: So mote it be.

WM: What man is he that liveth and shall not see death?

SW: Man walketh in a vain shadow; he heapeth up riches and cannot tell who shall gather them.

JW: When he dieth he shall carry nothing away; his glory shall not descend after him.

WM: If a man die; shall he live again?

SW: And they that sleep in the dust of the earth shall awake.

JW: And ye shall know that I am the Lord when I have brought you up out of your graves.

WM: Where now is our departed Brother?

SW: He is gone to that undiscovered country from whose bourne no traveler returns.

WM: Can we offer any precious thing to redeem him?

JW: We have not the ransom. The place that knew him shall know him no more forever.

WM: When our Brother died, did he carry nothing away with him?

Chaplain: He has fulfilled his destiny; naked came he into the world and naked he has departed out of it.

WM: Hear then the conclusion of the whole matter: It is the Lord only Who can give, and it is the Lord only Who hath taken away.

#### <u>Lambskin or White Leather Apron:</u>

WM: \* (Explaining this portion of the degree to the family can be done in this manner.) When our Brother first became a Mason, he was presented with certain symbols and tokens. The Apron is a very powerful symbol to all of us, and when he became a Mason, this is some of what was said to him:

(\* Assign this duty to a Brother who can present the lecture from memory with calm and deep feeling—have him address the Brother and the family.)

{ } —My Brother, this lambskin is an emblem of innocence and the badge of a Mason; more ancient than the Golden Fleece or the Roman Eagle; and when worthily worn, more honorable than the Star and Garter or any other Order that could be conferred upon him, at this time, or at any future period, by King, Prince, Potentate, or any other person, except he be a Mason. It is hoped that he wore it with equal pleasure to himself and honor to the Fraternity. It was his, his to wear throughout an honorable life and, at his death, to be placed upon the vessel containing his mortal remains, and be with them laid to rest in his final resting-place. Let its pure and spotless surface be an ever-present reminder of a purity of life and rectitude of conduct, a never-ending inspiration for nobler deeds, higher thoughts and greater achievements. And when at last his weary feet have come to the end of life's toilsome journey, may the record of his life and actions show as pure and spotless as this fair emblem. (Then place the Apron with the scroll.)

## The Sprig of Acacia:

WM: { } (Hold up sprig of Acacia, and ask all Masons to stand): The Evergreen, which once marked the temporary resting-place of one illustrious in Masonic legend, is an emblem of our faith in the immortality of the soul. By it we are reminded that we have an imperishable, immortal spirit, which survives this death, and which will never, never die. By it we are admonished that we too, like our Brother whose remains now lie before us, shall soon be clothed in the habiliments of death; yet, through the loving-kindness of the Supreme Grand Master, we may confidently hope that our souls will hereafter flourish in eternal spring.

(The WM goes to grave/ coffin/ table where the Scroll and Apron are displayed. He raises his right hand to the heavens and lowers his arm in three (3) equal sequences, depositing the Acacia on the 4<sup>th</sup>. The SW and JW follow, repeating the same arm sequence, then the Secretary, Chaplain, and then remainder of the Masons in attendance. Space constraints will determine if the other Brothers come 2x2 or in single file. All remain standing to either side until the last sprig of acacia is deposited.)

#### Funeral Grand Honors:

WM—(In former place, but now facing the urn/casket. Team adjusts to follow.)

- 1) (Raise both arms at a 45 degree angle, palms open and up to the heavens and say): "His Spirit hath ascended on high"---
- 2) (Lower arms and extend both in front of him, waist high, palms down and say): "We commit his body to the earth"---
- 3) (Cross both arms over chest and say): "And cherish his memory forever."

All Masons repeat two (2) more times together on the WM's lead. (Note well: If all Masons can be taught this beforehand it is best.)

WM: Reverently we commit the body of our Brother: earth to earth, ashes to ashes, and dust to dust. Though our Brother has passed beyond our mortal view, yet we can trustingly leave him in the hands of a beneficent Being, who doeth all things well; who is glorious in His holiness, wondrous in His power, and boundless in His goodness and love.

SW or { }: Soft and safe to thee, my Brother, be this earthly bed! Fragrant be the acacia that here shall bloom. May the year's earliest buds unfold their beauties o'er this thy resting-place. May each spring-time renew their loveliness. And here may the sweetness of the summer's last rose linger longest.

WM: With firm faith in the Supreme Grand Master of the Universe, we know that we shall meet once more in realms beyond the skies. Until then, dear friend and Brother, until then; Farewell.

<u>CHAP</u>: The Lord bless us and keep us. The Lord make His face to shine upon us and be gracious unto us. The Lord lift upon us the light of His countenance and give us peace. Amen!

Response: So mote it be.

WM: This concludes the Masonic service for our Brother. On behalf of our Lodge and Brothers, thank you again for allowing us the privilege of sharing in this celebration of life with you.

  - 3. It shall be a Masonic offense for any Mason other than the Grand Secretary to reproduce the Standard Work in plain (English) text of any language in any medium.

**Resolution:** Proposal to increase Grand Lodge "Per-Capita" assessment by the rate of inflation Recorded in the June (CPI), as published in September, of each year.

**Whereas:** It is the responsibility of the Grand Lodge to ensure the financial stability and viability of our organization, and

Whereas: The costs associated with maintaining our Masonic principles and supporting our various charitable endeavors have increased over the years, and

Whereas: The rate of inflation has a direct impact on the purchasing power of our Grand Lodge assessment and our ability to meet our financial obligations, and

**Whereas:** The U.S. Bureau of Labor Statistics publishes an index of inflation, referred to as the Consumer Price Index (CPI), which is updated each month of the year, and

Whereas: The specific CPI for "All Cities" is designated "U.S. BLS:CPI:CUUR0000SA0," and

Whereas: The monthly index values generally "stabilize" within three (3) months of initial publication, and

**Now, Therefore, be it Resolved,** that Section 7.03.A B.L. Revenue of the Grand Lodge" be amended as follows:

#### Sec. 7.03 B.L.

#### **Revenue for the General Fund**

- A. Every Lodge shall pay into the treasury of the Grand Lodge in support of Grand Lodge general activities as follows:

One dollar (\$1.00) shall be designated for contribution to each of the following organizations: the George Washington Masonic National Memorial Association, Washington/Idaho International Order of the Rainbow for Girls, Job's Daughters International of Washington and Washington Order of DeMolay. The exceptions are: Rev. 2017

**Report of the Committee on Finance:** The Committee on Finance, to whom was referred Resolution 2024-06 has considered the same and reports as follows; although there is some merit to the idea of factoring in the impact of inflation to our income stream, this could result in a growth rate in per capita which is far higher than most Members would be willing to accept. This is especially true during times of high inflation such as in the recent past.

## Resolution 2024-07 To Amend Appendix J Genealogy Chart

**Statement of Purpose**: Rationalize/simplify the Grand Lodge Genealogy Chart in Appendix J. of the WMC.


**Resolution:** To replace the existing Genealogical Chart of the Grand Lodge of Washington, found in Appendix J of the Washington Masonic Code (WMC) with a logically equivalent but simplified/rationalized version.

**Whereas:** The WMC contains a graphical chart of the "genealogical history" of the Grand Lodge of Washington tracing said history in a network diagram through twenty-four (24) different Grand Lodges with arrows representing "heredity" relationships between them that cross one another in thirty-eight (38) instances, and

**Whereas:** The same information can be represented in a similar network diagram that has only one (1) instance where lines cross, and

**Now, Therefore, be it Resolved,** that the Genealogical Chart in "Appendix J" of the WMC, shown below as Item A, be replaced in its entirety with the one below, labeled Item B.



# Resolution 2024-08 To Adopt an approved Ceremony for Presentation of a Past Master's Apron

**Statement of Purpose:** To present for approval at the Annual Communication, a ceremony to be used for presentation of a Past Master's apron, Past Deputy of the Grand Master, or Past Grand Master.

**Resolution:** Currently there is no formal process or ceremony for the presentation and exchange of the Past Master, Past Deputy of the Grand Master, or Past Grand Master's apron. Upon completing the discharge of his official duties, the outgoing Worshipful Master is usually presented with his Past Master's apron by the Lodge after the completion of the Installation Ceremony. The importance of conducting this ceremony with dignity and proper degree of solemnity and impressiveness must not be overlooked.

Whereas: We are taught that the apron is an emblem of innocence and the badge of a Mason, and

**Whereas:** It was hoped that we would wear our apron with equal pleasure to ourselves and honor to the Fraternity, and

Whereas: We are told it is ours, to wear throughout an honorable life, and

Whereas: The apron has long been a symbol of hard work, pride in a job well done and progress, and

**Now, Therefore, be it Resolved,** that the Past Master Apron ceremony be approved for use in this Grand Jurisdiction and a master copy thereof shall be kept on file in the Grand Lodge Office, available to Lodges upon request.

## **PAST MASTER APRON CEREMONY**

Upon completing the discharge of his official duties, the outgoing Worshipful Master is usually presented with his Past Master's apron by the Lodge after the completion of the Installation Ceremony.


The importance of conducting this ceremony with dignity and proper degree of solemnity and impressiveness must not be overlooked. This ceremony may be conducted in public or in the presence of Masons only.

NOTE: The language of the ceremony may be modified so that it might be useful for a Past Deputy of the Grand Master or even that of a Past Grand Master as appropriate.

At the appropriate time, the Worshipful Master (or Installing Master) should request that all Past Masters for this Lodge assemble in the West (or other appropriate area) forming a semi-circle as needed, arranging themselves by year of service or oldest year of service if he has served more than one term.

Once the Past Masters have aligned themselves, the ceremony can begin. The Worshipful Master or Installing Officer should ensure the Jr. Past Master shakes the hands of the Past Masters as he goes, starting with the oldest service year in the South and taking his place at the end as the youngest in service.

#### **EXAMPLE**:



WM/Installing Officer: \*\*\* Brethren of Lodge, No. when we begin our Masonic journey as Entered Apprentice Masons, we are taught that the apron is an emblem of innocence and the badge of a Mason; more ancient than the Golden Fleece or Roman Eagle; and when worthily worn, more honorable than the Star and Garter, or any other Order than could be conferred upon you at that time, or at any future period, by King, Prince, Potentate, or any other person, except he be a Mason.

It was hoped that you would wear this apron with equal pleasure to yourself and honor to the Fraternity. We are told it is ours, to wear throughout an honorable life and, at our death, to be placed upon the coffin that shall contain our mortal remains and be with them laid up in their final resting place.

The apron has long been a symbol of hard work, pride in a job well done and progress. As a man increases in knowledge and virtue, his responsibility to the Craft changes, consequently, so do the symbols on his apron.

As the Master of the Lodge, the Square is emblazed upon his apron and prompts us to square our actions by the Square of Virtue and to preserve that moral deportment among the members of his Lodge.

As a Past Master, he receives a new apron. Two of the symbols on the Past Master's apron, the Sun (or Star for Deputy of the Grand Master) and the Compasses are familiar. However, there is a peculiar additional device, the Quadrant (and a Square for the Deputy).

(Installing Master hands the Past Master's apron to the oldest service Past Master and he hands it to the next in line and so on until the apron reaches the Jr. Past Master while he continues with the ceremony below. As he finishes the ceremony, the Installing Master/Worshipful Master then assists in clothing the Jr. Past Master with his apron.)

(For Past Master or Past Grand Master) The Sun represents Light, the great luminary of nature, which rising in the East regularly diffuses light and luster to all within its circle. As a pattern for imitation, the Master of the Lodge is charged to spread and communicate light and instruction to the brethren of his Lodge.

The Sun also signifies that the Past Master has observed the sun at meridian height, the glory and beauty of the day, the setting sun in the West and the rising sun in the East.

(For Past Deputy of the Grand Master) The Star represents the deputed power and authority vested by the Grand Master. The office of Deputy of the Grand Master is reposed with great confidence in ability, prudence and zeal and he is instructed to visit and assist the Lodges as they may require or desire information and direction.

While we are reminded that every Mason is to symbolically use the Compasses to keep his actions within due bounds, the Quadrant identifies the angle at which the compasses are open, it is the Quadrant that measures those due bounds.

The Quadrant proves the angle of the Compasses are set to 60 degrees, this is the angle of an equilateral triangle, and is a symbol of balance.

The Square teaches you to regulate your actions and harmonize your conduct by the principles of morality and virtue.

As this apron and the symbols upon its surface are presented to you, in recognition of hard work and a job well done, as it is with your white apron, the badge of Masonry, we hope that you would also wear this with equal pleasure to yourself and honor to the Fraternity.

# Resolution 2024-09 To Amend Sec. 20.11 B.L.

**Statement of Purpose:** To strike the two-year limitation for reinstatement of failure to advance.

**Resolution:** To modify the language for reinstatement of a Mason declared failed to advance and allow a Lodge to vote to reinstate at any time or require him to re-petition.

Whereas: A Brother is a Brother forever, and

Whereas: The limitation on the timeline for reinstatement is unnecessary, and

Whereas: The Standard Work affirms their obligations can never be repudiated or laid aside, and

**Whereas:** Our Standard Work declares that a Mason's apron as his badge, and it is his, to wear throughout an honorable life, and

**Whereas:** A Lodge is self-governing, and entitled to manage its membership as it sees fit, under the auspices of the Constitutions and By-Laws of the Grand Lodge, and

**Now, Therefore, be it Resolved,** that the Washington Masonic Code, Sec 20.11 B.L. be amended to read as follows:

#### Sec. 20.11 B.L.

**Failure to advance**. An Entered Apprentice or Fellowcraft must show proficiency on that Degree and present himself for advancement to the next Degree within one (1) calendar year of receiving said Degree. That time may be extended by a simple majority vote at a Stated Communication of the Lodge. A candidate who does not meet the requirements to advance within the one (1) calendar year time limit may be dropped from the rolls of the Lodge by a simple majority vote at a Stated Communication of the Lodge and notified of such action.

Candidates dropped for failure to advance may be <u>immediately</u> reinstated (<u>within two (2) calendar years)</u> by a simple majority vote at a Stated Communication of the Lodge. (<u>After that time period</u>,) <u>If the vote is not favorable</u>, the <u>Lodge may require that</u> he (<u>must</u>) re-petition for the Degrees.

# Resolution 2024-10 To Amend Sec 15.03 B.L.

**Statement of Purpose:** To implement the Grand Master's Recommendation No. 1 to add completion of the Proficiency in Lodge Management exam as a requirement to be Master of a Lodge.

**Resolution:** To Amend Sec 15.03 B.L. to require Proficiency in Lodge Management to be Master of a Lodge.

Whereas: There is no current requirement for a Master of a Lodge to be proficient in the Standard work opening and closing, and

**Whereas:** There is no current requirement that a Master must have a basic understanding of the Washington Masonic Code, or how to access the information, even though when he is installed, he is charged with "The Book of Constitutions, you are to search at all times. Cause it to be read in your lodge so that none may pretend ignorance of the excellent precepts it enjoins.", and

**Now, Therefore, be it Resolved,** that the Sec 15.03 B.L. be amended to read as follows:

Sec. 15.03 B.L.

Officer Qualification. All Officers of a Lodge, either elected or appointed, shall be Master Masons in good standing who are voting members thereof, and who shall have passed a proficiency on the Third Degree. Exception: The Chaplain, Musician, and Tyler, who may be members of other Lodges. The Worshipful Master shall have achieved the Proficiency in Lodge Management Certificate prior to installation or shall have received dispensation from the Grand Master.

**Report of the Committee on Jurisprudence:** This Resolution is consistent with Masonic Law and Usages and is ready for consideration by the Grand Lodge. # Resolution 2024-11 To Amend Sec. 17.11 B.L.

**Statement of Purpose:** To implement Grand Master's Recommendation No. 2 to increase the cost to purchase an Endowed Life Membership through Grand Lodge.

**Resolution:** To modify Section 17.11 B.L. to increase the purchase price of an Endowed Life Membership.

Whereas: The cost of the Endowed Life Membership has not kept up with rising inflation, and

Whereas: The calculated cost based on the 2023 current minimum wage would be as follows:

- 1. Age 18 to 35 \$1250
- 2. Age 36 to 45 \$1100
- 3. Age 46 to 55 \$950
- 4. Age 56 to 65 \$800
- 5. Age 66 and over \$650, and

Whereas: Lodges struggle financially due to the low cost of Endowed Life Membership, and

**Now, Therefore, be it Resolved,** that Sec. 17.11 B.L. be amended to read as follows:

# Sec. 17.11 B.L. Life Membership Plans.

- A. through B. (No Change)
- C. Any member in good standing of this Grand Jurisdiction may purchase an Endowed Life Membership through the Grand Lodge Sponsored Plan and be hereby relieved from further payment of dues, but not assessments. Provisions of the Grand Lodge Sponsored Plan are as follows:
  - 1. The purchase price for Endowed Life Memberships shall (not be less than) be determined by calculation of the Current Minimum Hourly Wage (CMHW) in the State of Washington on January 1 of each year, rounded to the nearest \$50. The calculation will be as follows:
    - Age 18 to 35, inclusive (\$650) 80 x CMHW
    - Age 36 to 45, inclusive (\$600) 70 x CMHW
    - Age 46 to 55, inclusive (\$500) 60 x CMHW
    - Age 56 to 65, Inclusive (\$450) 50 x CMHW
    - Age 66 and Over (\$400) 40 x CMHW
  - 2. through 14. (No Change)

**Report of the Committee on Jurisprudence:** This Resolution is consistent with Masonic Law and Usages and is ready for consideration by the Grand Lodge. The Committee expresses no opinions as to the wisdom of the changes this Resolution proposes. As a By-Law Amendment, it requires a three-quarters (3/4) affirmative vote for adoption.

**Report of the Committee on Finance:** The Committee on Finance, to whom was referred Resolution 2024-11 has considered the same and reports as follows; this proposal will have a net positive impact to the finances of constituent lodges by increasing the amount invested in future purchases of life memberships

which will in turn increase the returns generated. It will also allow this cost structure to fluctuate based on a known and recognized methodology based on the prevailing minimum hourly wage.

# Resolution 2024-12 To Amend Sec. 6.02 B.L.

**Statement of Purpose:** To implement the Grand Master's Recommendation No. 3 to add Ritual Excellence Award to the Grand Lodge of Washington.

**Resolution:** To modify Section 6.02 B.L. to add recognition of Ritual Excellence in the Grand Lodge of Washington.

Whereas: Ritual Excellence should be prioritized and celebrated, and

Whereas: Brothers may obtain certification in Ritual Excellence, and

**Whereas:** Tracking of ritual excellence for all Lodges in the Grand Jurisdiction to have the ability to reach out when necessary, and

**Now, Therefore, be it Resolved,** that Sec. 6.02 B.L. be amended to read as follows:

#### Sec. 6.02 B.L.

**Certificates of Proficiency.** A Certificate of Proficiency shall be issued to any Brother who shall pass a satisfactory examination in all or part of the Standard Work before a Deputy of the Grand Master. The Certificate shall be attested by the Grand Master and by the Deputy of the Grand Master in his District and the Grand Secretary shall keep a record thereof. Certificates shall be issued for the periods of time shown:

- A. Excellence in Ritual Achievement Award All the Standard Work.
  - 1. Three years upon an examination with less than ten (10) errors,
  - 2. Two years, upon an examination with less than twenty-five (25) errors,
  - (3. One year, upon an examination with less than fifty errors.)
- B. (An individual Degree of the Standard Work.
  - 1. Three years, upon an examination with less than five errors,
  - 2. Two years, upon an examination with less than ten errors,
  - 3. One year, upon an examination with less than fifteen errors.)

Master's Certificate of Proficiency – The Warden's certificate plus the ability to confer all three degrees as Master and to present the Charge of all three degrees, the Moral Advantage of Geometry Lecture, the Apron Lecture, and at least one Degree Lecture (EA Master's Lecture, Middle Chamber Lecture, MM Historical Lecture)

- 1. Three years upon examination with less than ten (10) errors
- 2. Two years upon examination with less than twenty-five (25) errors
- C. Warden's Certificate of Proficiency The ability to open/close, call down, resume, labor to refreshment, and refreshment to labor on all three degrees from every station and place in the Lodge.
  - 1. Three years upon examination with less than ten (10) errors
  - 2. Two years upon examination with less than twenty-five (25) errors

<u>D.</u> Proficiency in Lodge Management – The ability to open/close, call down, resume, labor to refreshment, and refreshment to labor on all three degrees as Worshipful Master and successfully passing the written Proficiency in Lodge Management examination.

A reasonable opportunity shall be given during the examination to correct any error made.

<u>Lifetime Excellence in Ritual Achievement Award.</u> If any Brother earns the Ritual Excellence Certificate three (3) consecutive 3-year cycles, they will be awarded a Lifetime Ritual Excellence Certificate.

**Report of the Committee on Jurisprudence:** This Resolution is consistent with Masonic Law and Usages and is ready for consideration by the Grand Lodge. # Resolution 2024-13 To Amend Appendix I of the Washington Masonic Code

**Statement of Purpose:** To implement the Grand Master's recommendation No. 4 to adopt Ancient Landmarks for the Grand Lodge of Free and Accepted Masons of Washington.

**Resolution:** To Amend Appendix I from informational to adopted.

**Whereas:** Sec. 1.09 B.L. lists the requirements that must be satisfied for the Grand Lodge to recognize another Grand Lodge. Subsection E states, in part, that foreign Grand Lodge "Requires of its Constituent Lodges a strict adherence to the Ancient Landmarks...", and

Whereas: In 1951, the Conference of Grand Masters of North America created the Commission on Recognition which, in 1952, established guidelines for recognition of foreign jurisdictions. These include "Adherence to the Ancient Landmarks - specifically, a Belief in God, the Volume of the Sacred Law as an indispensable part of the Furniture of the Lodge, and the prohibition of the discussion of politics and religion", and

Whereas: Washington has never adopted Ancient Landmarks, but has included as Appendix I of the Washington Masonic Code the list of Ancient Landmarks formulated by Dr. Albert G. Mackey as well as a shorter list created by Dr. Roscoe Pound. All the items in Dr. Pound's list are included in Dr. Mackey's list, and

**Whereas:** In 2007, the Grand Lodge adopted Resolution 2007-01 which deleted a note to Dr. Mackey's list which stated that Washington did not allow the Grand Master to make a Mason on sight, and

Whereas: The charge given to a new Master Mason state, in part, "Our Ancient Landmarks you are to preserve and never suffer them to be infringed", and

**Whereas:** This charge is difficult to comply with when the Grand Lodge has not provided its members a list of the Ancient Landmarks, and

**Now, Therefore, be it Resolved,** that the Appendix I be amended to read as follows:

#### THE ANCIENT LANDMARKS

(The rituals and literature of Freemasonry contain many allusions to "THE ANCIENT LANDMARKS", the immemorial usages and customs, the foundation stones upon which modern Freemasonry has been erected. A noted American Masonic scholar, Dr. Albert G. Mackey, formulated a list of twenty five landmarks. Opinion as to the falidity of his list is not unanimous. Some Grand Lodges adopted his twenty five, some as many as fifty, others fewer in number. Bro. Roscoe Pound, a Past Deputy Grand Master of Massachusetts, and for many years Dean of the School of Law at Harvard, promulgated a list of seven.

The Grand Lodge of Washington never officially adopted a list of Ancient Landmarks. The following lists are included here as educational material only, in order that the origins and traditions, the usages and customs, the heritage of our Fraternity may be preserved.

# THE ANCIENT LANDMARKS as formulated by Dr. Albert G. Mackey) The Grand Lodge adopts the following as the Ancient Landmarks:

- 1. The modes of recognition.
- 2. The division of symbolic Masonry into three degrees.
- 3. The legend of the Third Degree.
- 4. The government of the Fraternity by a Grand Master elected from the body of the Craft.
- 5. The prerogative of the Grand Master to preside over any assembly of the Craft.
- 6. The prerogative of the Grand Master to grant dispensation for conferring degrees at irregular times.
- 7. The prerogative of the Grand Master to grant dispensations for the opening and holding of Lodges.
- 8. The prerogative of the Grand Master to make Masons at sight. [Rev. 2007]
- 9. The necessity for Masons to congregate in Lodges.
- 10. The government of every Lodge by a Master and two (2) Wardens.
- 11. The necessity of every Lodge when congregated being duly tyled.
- 12. The right of every Mason to be represented in all general meetings of the Craft and to instruct his representatives.
- 13. The right of every Mason to appeal from the decision of his Brethren, in Lodge convened, to the Grand Lodge or General Assembly of Masons.
- 14. (The right of every Mason to visit and sit in every regular Lodge. (SEE NOTE BELOW).) The prohibition of the discussion of partisan politics and organized religion in Lodge.
- 15. No visitor unknown to some Brother present as a Mason can enter a Lodge without undergoing an examination.
- 16. No Lodge can interfere in the business of another Lodge.
- 17. Every Freemason is amenable to the Laws and Regulations of the Masonic Jurisdiction in which he resides.
- 18. Every candidate must be a man, freeborn and of lawful age.
- 19. Every Mason must believe in the existence of (<del>God)</del> a Supreme Being as the Grand Architect of the Universe.
- 20. Every Mason must believe in a (resurrection) transition to a future life.

- 21. The "Book of the Law" is an indispensable part of the furniture of every Masonic Lodge.
- 22. That all men (in the sight of God) are equal and meet in the Lodge on one common level.
- 23. The secrecy of the Institution.
- 24. That Freemasonry consists of a Speculative Science founded on an Operative art.
- (25. The Landmarks of Masonry can never be changed. [Rev. 2007])

(NOTE: 14. An objection may be made to visitors. Washington Masonic Code, Sec. 13.10 B.L.

THE ANCIENT LANDMARKS as enunciated by Dr. Roscoe Pound in an address to the Conference of Grand Masters in North America, Washington, D.C., February 20, 1952:

- 1. Belief in God.
- 2. Belief in the persistence of personality, i.e., the immortality of the soul.
- 3. A "Book of the Law" as an indispensable part of the furniture of the Lodge.
- 4. The Legend of the Third Degree.
- 5. Secrecy.
- 6. The symbolism of the operative art.
- 7. A Mason must be a man, freeborn, and of age.)

# Resolution 2024-14 To Amend Sec. 13.14 B.L.

**Statement of Purpose:** To implement the Grand Master's Recommendation No. 5 to add health and safety concerns to cancel stated communications.

**Resolution:** To modify Section 13.14 B.L. to add health and safety concerns as a reason to cancel stated communications.

**Whereas:** The Health and Safety concerns of 2020 caused the necessity of violating the current Washington Masonic Code, and

**Whereas:** There are known and unknown health and safety concerns that can cause lodges to have no other choice but to violate the Washington Masonic Code, and

**Now, Therefore, be it Resolved,** that Sec. 13.14 B.L. be amended to read as follows:

Sec. 13.14 B.L. Inclement Weather and Cancellation of Stated Communication. The Worshipful Master of a Lodge may cancel a Lodge Stated Communication when inclement weather or other health and safety concerns are (is) hazardous to the safety of the Brethren.

**Report of the Committee on Jurisprudence:** This Resolution is consistent with Masonic Law and Usages and is ready for consideration by the Grand Lodge. The Committee expresses no opinions as to the wisdom of the changes this Resolution proposes. As a By-Law Amendment, it requires a three-quarters (3/4) affirmative vote for adoption.

**Report of the Committee on Finance:** The Committee on Finance, to whom was referred Resolution 2024-14 has considered the same and reports as follows; this proposal will have a negligible impact to the finances of Grand Lodge other than the cost of editing and reprinting the affected section of the Code.

# Resolution 2024-15 To Amend Sec. 8.13 B.L.

**Statement of Purpose:** Our goal is to decisively minimize confusion and significantly enhance decision-making clarity, ensuring a more streamlined and effective proposal of future resolutions.

**Resolution:** To amend Section 8.13 B.L. of the WMC to add an explanation of how an amendment is deemed "Out of Order". To enhance transparency and understanding, the Jurisprudence Committee will not only identify resolutions deemed "out-of-order" but also provide detailed explanations for their decisions. This resolution aims to clarify the reasoning behind these determinations, ensuring that all Lodges have a clear understanding during their Spring review, and

Whereas: Every year, numerous Lodges propose amendments to the Washington Masonic Code and the Standard Work. It's important to note that while some of these resolutions are found to be out of order and not eligible for consideration due to a variety of reasons, they are still included in the resolution packet. We understand that many members are keen to know why certain resolutions are deemed out of order. To address this curiosity and ensure transparency, we are requesting the Jurisprudence Committee to provide detailed explanations for each resolution classified as out of order, so every member can have a clear understanding of the decision-making process, and

Now, Therefore, be it Resolved, that 8.13 B.L. be amended and to read as follows:

Sec. 8.13 B.L.

**Jurisprudence.** The Committee shall consider and report upon all questions, documents, papers, decisions on Masonic Law and Usage, and proposed amendments to the Constitution, By-Laws, and Regulations. Should any proposed amendments be recommended to be 'Out of Order,' Jurisprudence will ensure transparency and understanding by providing an explanation alongside their decision.

# Resolution 2024-016 To Amend Sec. 10.04 B.L.

**Statement of Purpose:** Resolution for Transparent Financial Disclosures by Washington Masonic Charities (a.k.a. Washington Masonic Services).

**Resolution:** Add sections to Washington Masonic Code (WMC) to require Washington Masonic Charities to transparently report the category and dollar amount of every expenditure.

Whereas: Transparency is a core value within the Grand Lodge of Free and Accepted Masons of Washington (hereafter "Grand Lodge"), promoting trust, accountability, and responsible stewardship of resources, and

**Whereas:** The Grand Lodge seeks to maintain the highest standards of financial integrity and ensure that the outgoing moneys are used exclusively for legitimate and Masonic purposes, and

**Whereas:** The disclosure of outgoing monies purpose and amount will foster greater confidence among the members and the broader Masonic community, and

**Now, Therefore, be it Resolved,** that a new subsection of the Washington Masonic Code be added in "Section 10.04 B.L." to read as follows:

A. (No Change)

# B. Financial Transparency:

## 1: Disclosure Requirement

- a. Washington Masonic Charities (a.k.a. Washington Masonic Services), as the official financial charitable provider for the Grand Lodge, shall be required to annually disclose any and all transactions of outgoing monies.
- b. The disclosure shall include details of each transaction, such as purpose and amount, while omitting the names of the receiving parties or entities.

## 2: Implementation

- a. The disclosure shall be made accessible to all members of the Grand Lodge through an official publication, website, or any other suitable means of communication.
- b. The annual disclosure shall be made within 90 days of the end of each fiscal year of Washington Masonic Charities
- c. The Grand Lodge shall designate a committee responsible for overseeing the disclosure process and ensuring compliance with this resolution.

# 3: Confidentiality

a. To protect the privacy and confidentiality of the receiving parties or entities, the disclosure shall refrain from including any identifiable information in the outgoing monies transactions.

b. The designated committee mentioned in Section 2.c shall be bound by a strict code of confidentiality and shall not disclose any sensitive information beyond the scope of their responsibilities.

# 4: Review

- <u>a.</u> The Grand Lodge shall conduct periodic reviews to evaluate the effectiveness and compliance of this resolution.
- b. Any necessary amendments or improvements to the disclosure process shall be made based on the findings of the reviews.

# Resolution 2024-17 To Amend Sec. 8.08 B.L.

Statement of Purpose: Increase Accuracy of Grand Lodge Financial Reporting.

**Resolution:** To add requirements in the Washington Masonic Code (WMC), Section 8.08 Finance, to require accurate and complete financial statements be provided to its stakeholders, including those stakeholders identified in the WMC Section 1.03 Const., of the Most Worshipful Grand Lodge of Free and Accepted Masons of Washington (hereafter "Grand Lodge").

**Whereas:** The Grand Lodge is a multi-million-dollar organization, which should pride itself on world-class fiscal management practices and reporting, and

Whereas: The annual financial reporting provided to the stakeholders of the Grand Lodge in the Annual Proceedings routinely includes formatting and/or calculation errors (examples available upon request), lack complete information and/or explanatory footnotes to provide context and meaning to the financial information provided, and

Whereas: The Grand Lodge Committee on Finance routinely states that the Grand Lodge complies with Generally Accepted Accounting Principles (GAAP), yet still various errors recur annually, and

Whereas: GAAP includes ten "Key Principles," including that of "Sincerity" which states that a reporting entity should "...strive to provide an accurate and impartial depiction of a company's financial situation" (emphasis added), and "Materiality" which states a reporting entity "... must strive to <u>fully disclose all financial data</u> and accounting information in financial reports" (emphasis added), and

**Whereas:** Although it is "... not required for non-publicly traded companies to file GAAP-compliant financial statements...," yet the Securities and Exchange Commission (SEC) strongly encourages it, and it is generally viewed favorably by lenders, creditors, and investors, and

Whereas: The pro-forma information provided to Grand Lodge stakeholders each April includes only the current and proposed "budget" for the Grand Lodge, but does not include the Balance Sheet, Income Statement (a.k.a., Profit & Loss), or statement of cashflows for the Grand Lodge, nor does it include any of the financial statements of the related and/or subordinate entities, and

**Whereas:** The financial statements provided in Annual Proceedings do seem to include some additional information, yet lack sufficient clarity or explanation to easily identify the relationships between the various reported entities, and

**Whereas:** The confidence held by many Masons in this jurisdiction in the transparency and accuracy of the Grand Lodge's finances is low due to the recuring errors, and

**Now, Therefore, be it Resolved,** that Section 8.08 B.L. Finance be amended as follows:

#### Section 8.08 B.L.

**Finance.** The Committee shall:

- A. (No Change)
- B. Examine and compare the books, papers, vouchers and accounts of the Grand Master and the Grand Secretary and make detailed <u>GAAP compliant</u> reports thereon and submit the same to the Grand Lodge before the close of each Annual Communication; and report the financial condition

of the Grand Lodge. These annotated reports should include all assets/funds owned or managed by the Grand Lodge or any affiliated or financially associated entity (e.g., various endowment funds, Washington Masonic Charities, etc., along with all incomes and expenses, and include sufficient explanatory information to enable stakeholders to fully understand the information provided.

C. Present, before the close of each Annual Communication, an estimate of the probable expenses of the ensuing year <u>using GAAP compliant reports</u> (giving each class of expenditure under its proper heading), and recommend the appropriation of such sums as it shall deem necessary.

These should include an "actual to budget variance" report (not simply prior year and proposed budget) of incomes and expenses for the year.


